Chairman's Remarks

The Chairman indicated that he has been forwarding all information as it is received.

Director General's Report

The Director General presented his written report. Topics covered included:

-Pre-K

We have received notice that we will be funded for 1 full year for the Pre-K program for the schools in the socio-economic rank of 9 or 10. Rules specify that space must be available and that no additional funds for transportation will be granted. There will be no change to the Passe-Partout or Multi-age programs. We have 5 schools that are eligible (Dr. W. Keon, St-John's, Namur, Maniwaki Woodland and Queen Elizabeth). Maniwaki Woodland would be a good option because of the number of students that would benefit.

-Update: Namur:

Mr. O'Shea and Mr. Lamoureux along with Commissioner Brunke attended a Governing Board meeting last week. The Governing Board requested that an additional year of grandfathering be granted. Some concerns were raised about additional transportation time.

-Update: St. Michael's:

Ms. Ahern and Mr. Lamoureux met with the Governing Board (Commissioner Wilson was present) two weeks ago. Explanations were given about enhanced French delivery. Details were provided in terms of staffing, delivery models, etc..

-Reminder: Meeting at Heritage Hall at 6:00 pm. A bus will be leaving the Board Office at 5:15 pm for anyone requiring transportation.

-Planning and Review – Setting dates:

It was agreed that a meeting be scheduled April 15th at 7:00 pm.

-Update on school board elections:

We should be receiving a decision from the Minister by April 15th as to our request for five additional electoral divisions.

-Commissioner Ward 2:

R. Vézina provided details as to what has been done to publicize the availability of this position. Candidates have until April 19th to submit their application.

C-12/13-196 Future Extension

IT WAS MOVED by Commissioner Young that, as recommended by the Business Committee, the WQSB approve the minor changes to the building program for the new Wakefield School to provide the infrastructure for any possible future growth. Cost estimate: approximately \$65,000.00.

C-12/13-197 Energy Conservation

IT WAS MOVED by Commissioner Young that, as recommended by the Business Committee, the energy study for the New Wakefield School be approved as presented with a capital investment of \$588,000.00 with a return on investment of 13.9 years.

C-12/13-198 Budget 2013-2014

WHEREAS school boards have been receiving financial assistance as part of the equalization grant from the MELS since 2006 to provide a reduction rate to school taxes each year;

WHEREAS the 2013/2014 provincial budget contains a \$200 million reduction to school boards which represents the added financial assistance grant;

WHEREAS the MELS has identified that it will recuperate an amount equal to the financial assistance grant over a three-year period commencing in 2013-2014, at the rate of 50%(year 1); 25% (year 2) and 25% (year 3);

WHEREAS school boards have the decision of further reducing administrative expenses or removing the reduction rate on school taxes;

WHEREAS the budget rules and regulations are presently being drafted:

WHEREAS the WQSB's portion of the added financial assistance grant represents \$4.6 million;

WHEREAS the WQSB has undergone significant budget reductions in recent annual budgets;

IT WAS MOVED by Commissioner Young that, as recommended by the Business Committee, the reduction rate on taxation invoices be removed over a three year period commencing in 2013/2014 at the rate of 50%, at the rate of 25% for 2014-2015 and, at the rate of 25% for 2015-2016.

Geothermal Loan - Namur

IT WAS MOVED by Commissioner Young that, as recommended by the Business Committee, the School Board request final authorization from the MELS to borrow \$378 000 over a five-year period at an interest rate of 2.98%.
