WHEREAS it has been determined that a modification to the Dr. S.E. McDowell School's existing structure must be made to allow for the installation of the ventilation system, therefore increasing the cost of this project;

WHEREAS an urgent need has been identified at South Hull School by the Governing Board, the parents, the administration team, and the Buildings Department consisting of a relocation of the bus lanes and the parents drop off area;

WHEREAS the anticipated cost of this relocation is \$340,000;

WHEREAS the replacement of the heating system at Noranda School is not urgent at this time and can be postponed;

WHEREAS the MEESR has the authority to approve the transfer of allocated funds from one project to another;

IT WAS MOVED by Commissioner Dionne that the Director of Buildings, Equipment and Technology, Mr. Pascal Proulx, be mandated to request that the WQSB MB Projects funds be reallocated by the MEESR in the following way:

- -Postpone the Heating System Replacement project at Noranda School
- -Allocate an additional \$200,000 to the Gymnasium Equipment and Ventilation project at Dr. S.E. McDowell School

-Allocate \$340,000 to the South Hull bus lane relocation project.
