He encouraged the WQSB to continue on its path towards having student representation at Council. He extended an offer on behalf of the QFHSA and the Regional Association of West Quebecers (RAWQ) to assist and provide resources towards this goal. He encouraged the Council of Commissioners to look into the possibility of naming co-opted commissioners. He praised the WQSB for mentioning the student ombudsman on the front page of its website.
