WHEREAS the class-action lawsuit of unprecedented scope brought against all school boards, including the Western Québec School regarding parental fees (File 150-06-0000007-138 from Superior Court records);

WHEREAS the work performed under this mandate for over a year by Mr. Éric Blackburn and attorney Iris Montini, which led to the implementation of a satisfactory solution for the school board, approved by the court on July 18, 2018, and to the appointment of an administrator and GRICS firm to enable execution of the transaction;

WHEREAS the breadth of the workload and responsibilities assumed by Mr. Éric Blackburn and attorney Iris Montini, in addition to their duties within their respective school board;

WHEREAS that it is normal and expected that such burden and responsibilities be shared;

WHEREAS the will of the General Council of the Fédération des commissions scolaires du Québec (FCSQ) and the Board of Directors of QESBA to see their organizations take the lead in overseeing the file at its current stage, acceptance of full responsibility for it, and agreement of Mr. Éric Blackburn, attorney Iris Montini, and the Association des directions générales de commissions scolaires (ADIGECS) to the effect that this transfer of responsibilities will take place;

IT WAS MOVED by Commissioner Dionne that the Western Québec School Board:

- Transfer to the Quebec English School Boards Association the mandate to oversee, on its behalf, finalisation of the aforementioned file regarding the class-action lawsuit on parental school fees;
- Thank all the partners who contributed, directly or indirectly, to the proper handling of this file to date.
