WHEREAS the budget was produced on the anticipation of a normal school year and has no special provision for the challenges of Covid-19;

WHEREAS the 2020-2021 budget shows a deficit between projected revenues and expenses;

WHEREAS the deficit does not exceed the 15% of the available surplus and is aligned with the budget rules;

WHEREAS the proceeds of school taxes in the amount of \$16,503,735 as of June 30, 2020, was established using the official taxation rate for the 2020-2021 school year as registered in the Gazette;

WHEREAS the Ministry subsidy of \$3,599,735 will compensate for the balance of taxation revenue to reach the allocated amount;

WHEREAS the school tax interest rate is at 7% in the 2020-2021 Budget in conformity with the Gazette publication;

IT WAS MOVED by Commissioner Dionne that the 2020-2021 operating, investment and debt service budget be adopted and forwarded to the MEES, and that the tax rate be applied as published by the MEES.
