C-20/21-18 Autobus Outaouais – Approval of Contract Sale

WHEREAS by its resolution number C-16/17-218 adopted June 27, 2017, the WQSB awarded Autobus Outaouais a five-year school transportation contract;

WHEREAS Autobus Outaouais sold 46 of their bus routes and vehicles on October 1st, 2018 after having received the WQSB approval;

WHEREAS Autobus Outaouais sold another 4 of their bus routes and vehicles on July 1st, 2019 after having received the WQSB approval;

WHEREAS Autobus Outaouais informed the WQSB by way of a letter on September 8 of its interest to sell the balance of their contract representing 15 bus routes and vehicles to Autobus Campeau Inc.;

WHEREAS under the terms set out in its contract, Autobus Outaouais must obtain the WQSB's approval before proceeding with this final sale;
