Insurance Renewal

WHEREAS the Resolution C-19/20-10 authorized the school board to enter into a contract with **AON Risk Solutions** for damage insurance coverage for a period of 1 year with 2 optional renewal years;

WHEREAS AON Risk Solutions has notified the School Board that INTACT ASSURANCE, the insurance underwriter, will not exercise the renewal option for 2020/2021 under the same terms and conditions;

WHEREAS the Act respecting contracting by public bodies, section 13: "A contract involving an expenditure equal to or above the public tender

threshold specified in section 10 may be entered into by mutual agreement" and at section 13 (5) "in any other case determined by government regulation";

WHEREAS the Regulation respecting certain service contracts of public bodies, section 37 "A financial or banking service contract may be entered into by mutual agreement";

WHEREAS after validation with the Treasury Board, a damage insurance contract is a financial service contract;

WHEREAS the WQSB Purchasing Policy D-11, Section 5 states that the School Board may enter into contracts by mutual agreement in the cases permitted by the Act Respecting Contracting by Public Bodies and its regulations, even when the contract involves an expenditure equal to or above the tendering threshold for public tenders;

WHEREAS the School Board has requested and received a quote from **AON Risk Solutions** in the amount of \$104,399 for the damage insurance coverage for a period of one (1) year starting November 1, 2020, and ending October 31, 2021;

WHEREAS the School Board requested that the insurance coverage be for a period of 8 months, from November 1, 2020 to July 1, 2021 in order to align the renewal cycle with the financial year end of June 30;

WHEREAS the insurance underwriters have agreed to an 8-month period except for the property insurance coverage portion, which will remain a 12-month period;

WHEREAS the amount of the insurance contract will be prorated to \$80,378 before taxes;

IT WAS MOVED BY Commissioner Cornforth that the quote submitted by **AON Risk Solution**, in the amount of \$80,378 be approved.

WHEREAS the cost for replacing the roof fascia, the beam and the trusses is \$31,966.04;

WHEREAS this change order is over the 10% threshold;

WHEREAS the assigned budget can cover the cost of this change order;
