Request for Additional Wards - School Board Elections 2024

WHEREAS in accordance with section 6 of the *Act respecting school elections*, there shall be eight (8) electoral divisions for a school board where there are more than 10 000 but less than 30 000 electors, which is the situation of the Western Quebec School Board;

WHEREAS in accordance with section 7 of the *Act respecting school elections*, the Minister may, upon request, authorize a school board to establish up to five additional electoral divisions, if the Minister considers this warranted by the particularly large size of the territory of the school board, the number of local municipalities whose territory is comprised in the territory of the school board and the isolated location of the territory of a local municipality in the territory of the school board;

WHEREAS for the last school elections held in 2018 and 2020, the Minister authorized the Western Quebec School Board to establish three (3) additional electoral divisions on its territory;

WHEREAS there are presently eleven (11) electoral divisions on the territory of the Western Quebec School Board;

WHEREAS the Western Quebec School Board has a particularly large territory, covering over 90 000 square kilometers, making it the second largest board in the Province of Quebec;

WHEREAS the territory of the Western Quebec School Board comprises approximately 160 local municipalities;

WHEREAS several local municipalities located on the Western Quebec School Board territory are isolated;

WHEREAS it is in the best interest of the Western Quebec School Board and its students, parents, and taxpayers that it be permitted to establish more electoral divisions than the number provided for in section 6 of the *Act respecting school elections*, in order to ensure fair and adequate representation.

IT WAS MOVED by Parent-Commissioner Fortier that, according to the terms of section 7 of the *Act respecting school elections*, the Chairman of the Board be mandated to prepare and send a written request asking the Minister to authorize the Western Quebec School Board to establish three (3) more electoral divisions than the number provided for in section 6 of the said Act.

For equitable reasons and to conform with contractual requirements, a fixed repair price of \$90,000.00 will be specified;

WHEREAS contractors will be required to provide a breakdown of the costs associated with the repair before the work is performed;

WHEREAS the cost breakdown will be reviewed and validated by the professional and internal team before the project is executed;

WHEREAS if any amendments to the contract are required, they will be handled in accordance with By-law 30;

WHEREAS This strategy has been recommended by both the Director of Buildings & Technology, Mr. P. Proulx and the Contract Rules Compliance Officer (Alain Gendron, RARC);
