### Report of Findings & Conclusions by the Designated Person Following Two Investigations

Two complaints regarding alleged contraventions to the Code of Ethics and Professional Conduct for the Commissioners of the Western Quebec School Board (WQSB) were deposited with the Designated Person and a report of the findings of his investigations were shared with the Council during the in-camera session.

In the report, the Designated Person concluded that the Respondents were not in violation of the Code of Ethics. The total cost of the investigation by the Designated Person for the first complaint was \$55,508.38, and for the second complaint, it was \$26,613.49.

The total cost for all four complaints regarding alleged violations of the Code of Ethics and Professional Conduct for the Commissioners of the Western Quebec School Board was \$111,325.61.

WHEREAS this type of contract requires the authorization of the chief executive officer of the public body before the notice of a call for tender is published;

WHEREAS the contract is for 3 years with two renewal options of 12 months each;

WHEREAS the contract start date is July 1, 2025, and the end date is June 30, 2030;

WHEREAS the contract will cover the period of 3 years, from July 1, 2025, to June 30, 2028, with two (2) options for renewal of one year;

WHEREAS the value of this contract is estimated at \$630,000.00;

WHEREAS it is in the best interest of the Western Quebec School Board to issue our purchase order immediately after the tender opening date of December 20, 2024;

WHEREAS the ADG, Pascal Proulx and Procurement Officer, Alain Gendron, recommend issuing the purchase order to the lowest conforming bidder following the tender opening on December 20, 2024, and report the results of the tender to Council at its January meeting;
