# Adoption of the WQSB Code of Ethics for Employees and Anyone who Works with or Has Contact with Minors or Students with Ministry Exceptionalities

WHEREAS the government of Quebec decreed (O.C. 227-2055, March 5, 2025) that March 5, 2025, be set as the date of coming into force of section 14 of the Act to reinforce the protection of students, including with regard to acts of sexual violence (2024, chapter 9);

WHEREAS section 14 of the Act introduced modifications under section 258.0.1. of the Education Act (chapter I-13.3) for school service centres and school boards, requiring the adoption of a Code of Ethics for employees and anyone who works with or has contact with minors or students with Ministry exceptionalities;

WHEREAS every educational organization's Code of Ethics must include, without omission in whole or in part of the various sections prescribed by the Ministère de l'Éducation;

WHEREAS the legislation allows school organizations to make additions to any other element of the Code of Ethics deemed relevant, in light of the realities of their organization;

WHEREAS Council has received recommendations from QESBA regarding proposed amendments to the Code of Ethics;

WHEREAS terminology contained in the prescribed document, regarding students with particular profiles, was determined to be outdated and inappropriate;

WHEREAS updated terminology regarding students with particular profiles was developed in concert with members of the General Directorate, Human Resources department, Complementary Services department, and the Special Education Advisory Committee;

WHEREAS the Code of Ethics must be published on the organization's website and made accessible to any person who requests it;

IT WAS MOVED by Commissioner Cornforth and seconded by Commissioner Goldsbrough that Council adopt the WQSB Code of Ethics as outlined in the documentation submitted.

#### C-24/25-136 Derogation Request No. 25520G001 to the WQSB Purchasing Policy No. D-11 to Enter Into a Mutual Agreement with Spiralis for Training Sessions – Dispute Prevention and Resolution

WHEREAS the Western Quebec School Board wishes to enter into a mutual agreement contract with Spiralis for the training needs on our Dispute Prevention and Resolution Program for 2024-2025;

WHEREAS the ADGESBQ has provided funding through the DG Plan as well as the DG-led DSREA projects of \$50,000.00 to the Western Quebec School Board for training on Dispute Prevention and Resolution;

WHEREAS last year's supplier for this training cancelled his participation in the training, as there are not enough participants;

WHEREAS Spiralis has been contacted and can accommodate the WQSB and meet our specific needs;

WHEREAS section 6.4 of the WQSB Purchasing Policy, "Mutual Agreement Contract" states that:

- a) The School Board may use a mutual agreement process for contracts of an estimated value below \$5,000.00;
- b) The School Board communicates directly with at least one supplier, indicating the good(s), service(s), or construction work required and any other relevant information;
- c) Before entering into a contract by mutual agreement, the School Board must ensure that fair prices and conditions are obtained:

WHEREAS the value of this contract to be entered into by mutual agreement is above the threshold of \$5,000.00;

WHEREAS the tendering process for a contract above \$5,000.00 requires three written quotes;

WHEREAS Policy D-11, *s. 7*, provides an exception to the tendering process:

Except for contracts where the estimated expenditure is equal to or above the thresholds established by the Act Respecting Contracting by Public Bodies, the Council of Commissioners may authorize the School Board, in exceptional circumstances and for legitimate reasons, to enter into a contract without following the tendering processes described herein.

WHEREAS Spiralis has quoted \$13,853.34 for the training sessions (Spring 2025 and Autumn 2025);

WHEREAS the administration is recommending the derogation based on:

- The Western Quebec School Board DPR model has been developed in partnership with Thierry Bériault and is specific to us.
- Thierry Bériault is no longer offering support for this initiative.
- Spiralis is willing to work with the WQSB DPR framework to support the initiative in a timely manner and deliver bilingual training.

WHEREAS the Executive Committee recommends by its resolution # E-24/25-71 to approve the derogation request to enter into a mutual agreement contract with Spiralis for the Dispute Prevention and Resolution training;
